RENTAL AGREEMENT

Spring Mill Bible Camp, Inc. is a not-for-profit religious organization founded and operated upon the perpetuation of New Testament Christian principles. SMBC's bylaws provide that the corporation's purpose is to establish, promote, and perpetuate a Christian camp to provide the youth a wholesome environment and recreation under the guidance and supervision of Christians while instructing the youth in the knowledge of God's word. SMBC is fully committed to this purpose being fulfilled in each and every activity which occurs at the camp facilities. To this end, SMBC requires that all uses of the camp facilities not conducted under the direct control of its board of directors must adhere to New Testament principles. By renting the camp facilities, you and your group agree to comply with this requirement.

The \$250.00 Damage Deposit is required to hold a reservation. Camp cannot be held until deposit is received. Rental Fees must be paid *in full* immediately upon arrival.

Cancellation requires a 30 day written notice or the \$250.00 damage deposit will be retained to cover loss of rental opportunity.

*The \$250 Damage Deposit will be refunded if there has been no damage to SMBC facilities and your group leaves the grounds clean and in accordance with the check-out checklist. A cleaning fee of \$25 per hour will be charged for any cleanup required after your group checks out. If there is no damage and the camp is left clean, a check for \$250 Damage Deposit will be mailed to you within 5 working days of your departure.

Note: An overnight rental is a 24-hour period. A daytime rental is from 8am to 11 pm. Check in/out times will be arranged with resident director, as noted at the top of this agreement.

Smoking is prohibited on SMBC property.

Rental groups shall furnish all food, personal toiletries, bedding, and first aid supplies.
